Pursuant to Administrative Law Judge F. Joseph Brady's Interim Order Granting Joint Motion for Stay (the "Stay Order"), issued February 6, 2023, the Delaware County Regional Water Quality Control Authority ("DELCORA") is filing and serving this written status report detailing the procedural status and litigation schedule for the Complaint for Declaratory Judgment filed in the Court of Common Pleas, Delaware County, in Docket No. CV-2023-000494 ("Declaratory Judgment Matter") and also for the Receiver for the City of Chester's Motion of Debtor Pursuant to Section 362 of the Bankruptcy Code for

Entry of an Order Enforcing the Automatic Stay of Proceeding Pending Before the Pennsylvania Public Utilities [sic] Commission ("Bankruptcy Matter").

DELCORA Declaratory Judgment

The presiding Judge cancelled the October 12, 2023 hearing and advised parties that hearings on this matter would be postponed until a decision was rendered in the pending Appeal in Commonwealth Court at 1347 CD 2022, regarding the jurisdiction of the Court of Common Pleas. The Commonwealth Court initially scheduled this matter for oral argument on May 7, 2024 but notified the parties on April 29, 2024 that the Court would decide the matter on the submitted briefs.

UNIVEST Resignation as Trustee

This matter was scheduled for the trial term of March 4th, 2024 to March 15th, 2024. The parties reached an amicable resolution and entered a Stipulation and Final Decree wherein Delcora agreed to complete a good faith search for a successor trustee for 30 days from the date of the Order. That search is ongoing as of the date of this correspondence.

Bankruptcy

The status of the Bankruptcy and Aqua's appeal of Judge Ashley M. Chan's Order granting the City of Chester's Motion to Enforce Stay remains unchanged. The parties filed their briefs and there has been no further movement. Aqua also filed a Motion for Relief from Stay in the Bankruptcy Court on February 8, 2024 which was denied by an Order dated April 11, 2024 on the grounds that the previously filed appeal divested the Bankruptcy Court of jurisdiction to rule on the Motion.

Aqua's Declaratory Judgment

Aqua filed a civil complaint for declaratory judgment and injunctive relief against DELCORA on June 16, 2023. DELCORA filed an Answer to Preliminary Objections and a corresponding brief on December 1, 2023. At this time no hearings have been scheduled or Orders entered related to the Answer or Preliminary Objections.
