Enclosed, please find Eligo Energy PA, LLC's ("Eligo") Retail Choice Activity Reports for the 2023 calendar year. Eligo requests that the information contained within the reports be treated as confidential by the Pennsylvania Public Utility Commission ("Commission").

The electric utility business is highly competitive, and it is imperative that public disclosure of the confidential information contained in the Report be avoided. Eligo is not a publicly traded company and, therefore, all of its information is highly confidential and is available only to those individuals on a need to know basis. The public disclosure of Eligo's information would create an extreme hardship for Eligo because it would give an unfair advantage to Eligo's competitors and would likely result in substantial economic damages to Eligo.

WHEREFORE, Eligo respectfully requests that the Commission protect the confidentiality of the information identified as Confidential in the Report, and that this information not be made a part of the public record.

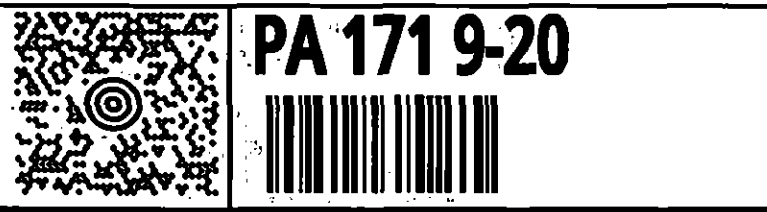

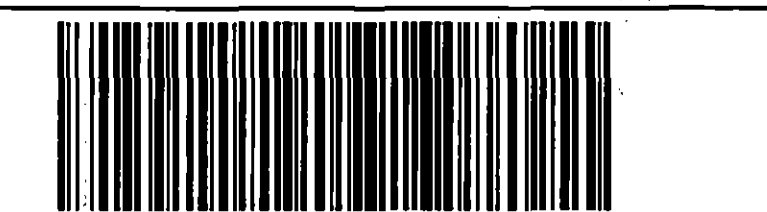


