PREHEARING MEMORANDUM OF PENNSYLVANIA-AMERICAN WATER COMPANY

Pennsylvania-American Water Company ("PAWC""), pursuant to 52 Pa. Code §5.222(d) and in compliance with the Prehearing Conference Order of the Honorable Administrative Law Judge ("ALJ") Mark A. Hoyer, dated May 7, 2024, hereby files this Prehearing Memorandum in the above-captioned proceedings, and states as follows:

I. INTRODUCTION AND PROCEDURAL HISTORY

On August 11, 2023, at Docket Nos. M-2023-3042180 and I-2023-3042312, an Ex-Parte Emergency Order was issued which instituted an investigation into whether the Pennsylvania Public Utility Commission ("Commission") should order a capable public utility to acquire the Venango Water Company ("Venango") owned by the Blaine Edwin Rhodes Estate ("Rhodes Estate") and directed Aqua Pennsylvania, Inc. ("Aqua") to act as Receiver of Venango.

On January 3, 2024, the Bureau of Investigation and Enforcement ("I&E") filed a

Petition requesting that the Commission open a Section 529 Investigation into whether the Commission should order a capable public utility to acquire any or all of the other small water and wastewater utilities owned by the Rhodes Estate in addition to Venango (together with Venango, the "Rhodes Utilities") assigned Docket No. P-2024-3045205.

On February 15, 2024, I&E filed a Petition for Consolidation pursuant to 52 Pa. Code §§5.41 and 5.81 to formally consolidate Docket Nos. M-2023-3042180, I-2023-3042312 and P-2024-3045205.¹

On March 15, 2024, the Office of Consumer Advocate ("OCA") filed a Notice of Intervention and Public Statement in this proceeding.

OSBA filed a Notice of Intervention, Public Statement and Verification on April 3,

2024.

On April 1, 2024, PAWC filed a Petition to Intervene in this proceeding.

On May 2, 2024, an Initial Telephone Prehearing Conference Notice was issued

scheduling a prehearing conference for May 21, 2024 at 10:00am before ALJ Hoyer.

On May 7, 2024, a Prehearing Conference Order was issued.

III. <u>SERVICE OF DOCUMENTS</u>

PAWC's attorney is authorized to accept service on behalf of PAWC in this proceeding. PAWC agrees to receive service of documents electronically in this proceeding and requests that all listed counsel for PAWC receive electronic service.

IV. <u>ISSUES</u>

The ultimate issue in this proceeding is whether or not the Commission should order the acquisition of any or all of the Rhodes Utilities by a capable public utility pursuant to Section 529 of the Public Utility Code. Section 529(a) lists six determinations that must be made by the Commission, after notice and an opportunity to be heard, to order such an acquisition. In making these determinations, Section 529(c) delineates several factors which the Commission shall consider.

PAWC, as a capable and proximate water and wastewater provider to the Rhodes Utilities, may be directly affected by the outcome of this proceeding if it is established that the acquisition of the Rhodes Utilities would be in the public interest and in compliance with the provisions of Section 529.

V. <u>WITNESSES</u>

PAWC has not identified any witnesses at this time or determined whether it will be submitting testimony.

VI. <u>LITIGATION SCHEDULE</u>

PAWC will work with ALJ Hoyer and all parties to develop a mutually agreeable litigation schedule.

VII. <u>SETTLEMENT</u>

PAWC is willing to participate settlement discussions in this matter.
