On April 11, 2024, the Pennsylvania Public Utility Commission (Commission) received AuctionURenergy LLC's Application for an Electric Generation Supplier (EGS) license. On May 1, 2024, AuctionURenergy LLC's responses to the Deficiency Letter were received. In order for us to complete our analysis of AuctionURenergy LLC's EGS Application, the Commission's Energy Industry Group requires answers to the attached questions.



The surety bond references the name of the Applicant as AUCTIONUREENERGY LLC, however, the name of the Applicant per registration with the PA Department of State is AuctionURenergy LLC. The name of the principal on the original financial instrument must match the Applicant’s registered name with the Pennsylvania Department of State’s listing EXACTLY, including punctuation, spacing and capitalization. Please provide an updated financial security with the appropriate corrections.
2. Reference Application, Section 7.b, Financial Fitness – Please provide three recent consecutive months of bank statements. Please provide financial statements and/or tax returns for year ending 2023, if the company filed for an extension please provide a copy of the extension.
