Re: Pennsylvania Public Utility Commission Bureau of Investigation & Enforcement ("I&E") v. Peoples Natural Gas Company LLC ("Peoples"), Docket No. M-2023-3024990, in front of the Pennsylvania Public Utility Commission ("Commission")

Dear Secretary Chiavetta,

Per the Final Opinion and Order issued on May 9, 2024 by the Commission in the above-referenced matter, the Commission approved, without modification, the Joint Petition for Approval of Settlement ("Joint Petition") executed by I & E and Peoples (together, the "Parties"). In the Joint Petition, the Parties had agreed that Peoples would pay a civil penalty in the amount of \$250,000.

Per the Final Order, and in accordance with Section 3301 of the Public Utility Code, 66 Pa. C.S. Section 3301, Peoples is to pay the civil penalty within thirty (30) days of the Final Order. Enclosed please find a cashier's check issued by PNC Bank, No. 481430, dated May 20, 2024, made payable to the Commonwealth of Pennsylvania in the amount of \$250,000, the full amount of the agreed-upon and approved civil penalty.



