- 1.) In your Verified Statement of Applicant, you mention that you worked for Allied Van Lines. How long did you work with Allied Van Lines? It also appears that you have interstate authority to transport household goods. How long have you operated interstate moving of household goods?
  
- 2.) You failed to adequately answer all aspects of question #5 of the Verified Statement of Applicant.
  - a. Your system for conducting criminal background checks. Please review Title 52 Pa Code §31.134 – Criminal History to see what is required of motor carriers.
    - i. How often will the criminal background checks be conducted?
    - ii. How will you maintain records (record retention) of the criminal background checks performed?
  
  - b. Your system for conducting driver license/history checks. Please review Title 52 Pa Code §37.204, 49 CFR §391.25 to see what is required of motor carriers.
    - i. How often will driver license/history checks be conducted.
    - ii. How will you maintain records of driver license/history checks?
  
- 3.) Question #7 of the application asks you to describe your vehicle safety program. Do you conduct any pre/post trip inspections on the vehicles, and what does that entail?
