CRIMINAL HISTORY POLICY

Barnett Unlimited, Inc Criminal History Policy

1. All employees of Barnett Unlimited, Inc will require a Pennsylvania State Police Criminal History Report from every state the individual resided in within the last 12 months.
2. All employees will be required to have a criminal history report completed every 2 years from the date of the last report.
3. No employee shall be permitted to provide moving services in a shipper's dwelling when the person was convicted of a felony or a misdemeanor under the laws of the Commonwealth or under the laws of another jurisdiction, to the extent the conviction relates adversely to that person's suitability to provide service safely and legally.
4. Record Retention: A copy of the criminal history shall be maintained by Barnett Unlimited, Inc. for at least 3 years.
