NOTE 6 - Hourly rates will increase by **\$10.00** per hour per flight when pickup or delivery is above the third (3rd) floor.

NOTE 7 - When a piano is included in the shipment, an additional handling fee of **\$300.00** per piano will be assessed in addition to all other applicable charges. When other bulky items are included in the shipment, an additional handling fee of **\$75.00** per bulky item will be assessed in addition to all other applicable charges.

NOTE 8 - Any tolls, parking fees or parking tickets incurred at the client's origin or destination location will be the responsibility of the client and added to the carrier's charges and billed to the customer.
