Dear Secretary Chiavetta:

To date, Aqua Pennsylvania, Inc. (“AP”) and Aqua Pennsylvania Wastewater, Inc. (“APW”), (collectively, “Aqua PA” or the “Company”) have been served with a number of formal complaints in the above-captioned matter and anticipates that additional formal complaints will be filed as this proceeding continues. The Company further anticipates that all complaints filed with respect to its proposed rate increases will be consolidated into this proceeding. Accordingly, Aqua PA will rely upon 52 Pa. Code § 5.61(d), which provides:

For complaints which are docketed with Commission-instituted rate proceedings, an answer may be filed within 10 days of date of service. However, an answer is not required, except as may be directed by the Commission or the presiding officer.

As such, pursuant to 52 Pa. Code § 5.61(d), Aqua PA does not plan to file answers to any of the complaints served on the Company to date. If the Pennsylvania Public Utility Commission (“Commission”) believes that answers should be filed to any specific complaints and hereafter directs Aqua PA to do so, we request that the Company be provided 20-days from the date of such directive to file answers to such complaints.
