Re: Electric Generation Supplier License of American Electric Rates LLC

Dear Ms. Mann:

On February 21, 2024, ENERGY ZEBRA, LLC (ENERGY ZEBRA) filed a request with the Pennsylvania Public Utility Commission (Commission) to change the name on its license to provide electric generation services, as a broker/marketer, to American Electric Rates LLC (American Electric Rates).

Currently, ENERGY ZEBRA is licensed as ENERGY ZEBRA, LLC as a broker/marketer to residential, small commercial (25 kW and under demand), large commercial (over 25 kW demand), industrial, and governmental customers, as well as residential and small commercial (limited to mixed meters) customers, pursuant to the Commission's Secretarial Letter served March 25, 2011 at Docket No. M-2009-2082042, in all of the electric distribution company service territories throughout the Commonwealth of Pennsylvania.

American Electric Rates has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission. Furthermore, American Electric Rates has provided an update to its financial security instrument reflecting its new name.

Therefore, the Commission approves, by this Secretarial Letter, the change of ENERGY ZEBRA, LLC's name on its license for the provision of electric generation services as a broker/marketer.

The Secretary's Bureau will issue a new license to American Electric Rates LLC the right to begin to offer, render, furnish, or supply electric generation services as a broker/marketer to residential, small commercial (25 kW and under demand), large commercial (over 25 kW demand), industrial, and governmental customers, as well as residential and small commercial (limited to mixed meters) customers, pursuant to the Commission's Secretarial Letter served March 25, 2011 at Docket No. M-2009-2082042, in all of the electric distribution company service territories throughout the Commonwealth of Pennsylvania.

The Secretary's Bureau and the Bureau of Administration, Financial and Assessments will update the company's name in their computer systems and lists, as appropriate, to be American Electric Rates LLC.
