

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Any Day, Any Hour: two (2) hours for two men crew and three (3) hours for three or more men crew.

NOTE 5 - Any tolls, parking fees or parking tickets incurred at the client's origin or destination location will be the responsibility of the client and added to the carrier's charges and billed to the customer.
