To Whom it May Concern:

On April 25, 2024, the Commission entered a Tentative Order, Docket No. M-2024-3047909, which advised James & Debra Ament t/a We-Haul Moving that it was not in compliance with the insurance requirements of 66 Pa.C.S. § 512. The Tentative Order advised James & Debra Ament t/a We-Haul Moving, that it must, within 30 days of publication of the Tentative Order, either have acceptable evidence of insurance filed with the Commission or cancel their authority or file comments to the Tentative Order. The Tentative Order advised Company Name that, if it failed to respond, its certificate of public convenience would be cancelled. The Tentative Order was served on James & Debra Ament t/a We-Haul Moving and published in the *Pennsylvania Bulletin*.

James & Debra Ament t/a We-Haul Moving failed to respond to the April 25, 2024, Tentative Order and remains in non-compliance with the insurance requirements of the Public Utility Code at 66 Pa.C.S. § 512.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until a new application for authority is submitted. Additionally, all unpaid fines or assessments accrued while you had authority, are still due.

YOU ARE ADVISED: That the certificate(s) issued at Docket No. A-00119270 be and is hereby *cancelled*, and all rights, powers, and privileges granted thereby shall forthwith cease and terminate.
