Per the August 29, 2019 Opinion and Order entered in the formal complaint matter of Ultimate Sports Company, Inc. v. PPL Electric, the Company was ordered to pay a \$2,000.00 civil penalty.

Per the October 27, 2022 Opinion and Order entered in the formal complaint of Patricia J. Vaughn v. PPL Electric, the Company was ordered to pay a \$500.00 civil penalty.

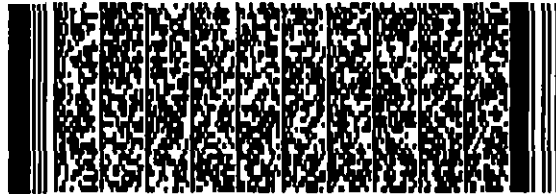

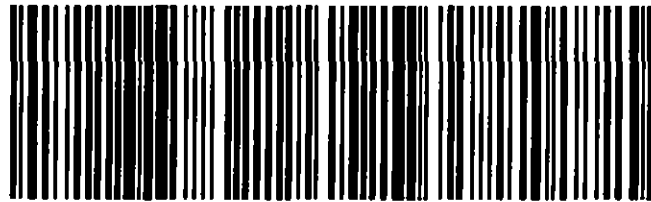
