Dear Secretary Chiavetta:

In accordance with the Interim Order issued on March 1, 2024, in the above-referenced matter, this letter serves as a status report on behalf of FirstEnergy Pennsylvania Electric Company on behalf of its Met-Ed Rate District (the "Company").<sup>1</sup> The Company provided its witness identification on April 26, 2024. To date, the Company has not received Ms. Farina's witness information. Therefore, the Company anticipates that it will only need to present one witness, Stephen DuBrey, in order to rebut any factual testimony offered at that time. Please note, that the Company's witness has changed since its April 26, 2024 notification.

Based upon this information, the Company believes that the above-referenced proceeding is ready to proceed to an evidentiary hearing. Counsel for the Company has attempted to confer with Ms. Farina regarding the scheduling of an evidentiary hearing. To date, the Company has been unable to reach Ms. Farina. The March 1, 2024 Interim Order stated that the parties should provide all dates in August and September of 2024 in which the parties and their witnesses are unavailable and whether the hearing should take place telephonically or in-person. Therefore, the Company respectfully requests a one-day telephonic evidentiary hearing to be held consistent with the Company's availability.

The Company has very limited availability for hearings in August and respectfully requests the hearing to be held in September. In September, the Company is unavailable on the following dates:


