**PETITION OF DES NATURAL GAS LLC
TO ABANDON ITS NATURAL GAS SUPPLIER LICENSE**

NOW COMES DES Natural Gas LLC, pursuant to 52 Pa Code §§ 62.112, and hereby Petitions the Pennsylvania Public Utility Commission (“Commission”) for authorization to abandon its natural gas supplier (“NGS”) license. In support of its Petition for Abandonment, DES Natural Gas LLC states as follows:

1. DES Natural Gas LLC’s (“DES”) has been a natural gas supplier licensed by the Commission since at least 2009.
2. On April 27, 2022, DES notified the Commission of its intention to transfer the bulk of its customers to another supplier by assigning their contracts to Interstate Gas Supply, Inc.- Dominion Energy Solutions, LLC. Those transfers have been completed.
3. On January 1, 2023, DES notified the Commission of its name change to DES Natural Gas LLC.
4. DES has not served any customers since 2022.
5. The Commission’s staff maintains a checklist of items that are required to be included in a Petition for Abandonment of an NGS license and these items are addressed below seriatim.

a. **Service on Statutory Parties and impacted Utilities.** See Certificate of Service attached hereto.

b. **Notice to Customers.** DES no longer has any customers and no notice is required.

c. **Transfer of customer supply responsibility.** DES has no customers and no supply obligations.

d. **Resolution of any Active Proceedings.** The attached email from the Bureau of Consumer Services (**Attachment 1**) confirms that there are **no** active informal proceedings involving DES and the attached docket sheet print out (**Attachment 2**) from the Commission's website, demonstrates that there are no active proceedings involving DES.


e. **Commission Fees and Assessments.** Attached hereto as **Attachment 3** is an email from the Commission's Bureau of Administration demonstrating that DES is current with all fees and assessments.

f. **Financial Security.** DES has no outstanding financial security with any Pennsylvania NGDC, as it has not served customers in over a year.

WHEREFORE, DES Natural Gas LLC respectfully requests that the Commission grant its Petition and authorize the abandonment of its natural gas supplier license at **Docket No. A-125002**.
