As per one of the litigation orders/mailling correspondence you et al set to me, Met Ed offered to relocate the SMART Meter to a mutually agreed location. In my recent letter to you et al I agreed. The questions are: (1) What is the cost to move it? (2) Will Met Ed assume the cost?

I am still entitled to a hearing with my witnesses. This is about questionable health issue as documented in the report I previously sent you et al and not about the operation and business cost that Met Ed/First Energy Service Company focuses on in their response dated June 14, 2024.

I am not available to attend hearings on August 5, 2024 to August 7, 2024 and not available September 25, 2024 to September 30, 2024.

I write for clarification which Met Ed/First Energy Service Company address I should use for correspondence and I hope for a response. On various notices sent to me Met Ed/First Energy Service Company includes a variety of addresses for example Greensburg, PA, Reading, PA, and Akron, OH. One address should suffice. Please let me know if sending correspondence to only Greensburg, PA is sufficient. I should not have to send correspondence to 2-3 Met Ed/First Energy Service Company addresses. If Met Ed/First Energy Service Company does not respond, then any single one of the addresses should be sufficient. Before bringing this to your attention, I did call the three phone numbers provided by Met Ed/First Energy Service Company and no one picked up the call at any of the numbers. The outgoing message said the caller can dial an extension, but Met Ed/First Energy Service Company never provided an extension and then disconnected my call. Thank you for any and all assistance in the above matters.
