To Secretary- Pennsylvania PUC,

We are sending this letter as a Petition to have our Authority reinstated. We were suspended because our insurance company did not send Form E to the PUC. Apparently, only Form H was sent but not Form E. We were assured that both forms were sent after multiple requests were made by We-Haul Moving and the PUC to send all appropriate forms. Unfortunately, this did not happen in a timely manner by Chubb/USI.

We have been in business for over 20 years and do not have any complaints. Every effort has been made to remain compliant. We spoke with the PUC earlier and were informed that we should be checking our status on your site to ensure that all insurance forms have been filed properly when our policies are up for renewal. We were unaware of this. Going forward, we will ensure that we do this. Having said this, Chubb attempted to send Form E. We were informed it was rejected and we would have to Petition the PUC to be reinstated.

Please know that we have never had a lapse in our insurance and will continue to remain compliant with all the PUC's insurance requirements if our Petition for Reinstatement is granted.

We have included all correspondence between us and our insurance company. If you require any further information, please let us know. Thank you for your consideration with this matter.

Please see below from the carrier:

"The PA PUC called me back and stated that they would reach out to your Client to get their authority to operate their business once again and stay within rules and regulations. Once they have been granted authority the Forms would need to be re-sent. So from a Chubb standpoint, there is nothing we can do until Authority to Operate has been granted an approved. This is something that the PA PUC and the Insured need to work out. If we try and submit any Forms again, they will be rejected due to the Insureds Authority being revoked.
