Dear Mr. Sheehan:

On May 16, 2024, the Pennsylvania Public Utility Commission (Commission) received Astral Energy, LLC's application to withdraw its Electric Generation Supplier license. The application was submitted by the Law Firm of Genova Burns, LLC, representing the Bankruptcy Trustee for Astral Energy, LLC. In order for us to complete our analysis of your application, and the submitted letter, the Energy Industry Group requires answers to the attached questions.

Please use the Commission's efilings system or an overnight delivery service to submit the requested information to the Secretary of the Commission **within 30 days** from the date of this letter. 
