
Dear Secretary Chiavetta:

Pursuant to the Pennsylvania Public Utility Commission's Order dated July 11, 2024 ("July 11 Order"), FirstEnergy Pennsylvania Electric Company ("FE PA") is to file its revised Amended Universal Service and Energy Conservation Plan ("USECP") within 20 days or by July 31, 2024.


