THIRD INTERIM ORDER

On April 30, 2024, the International Brotherhood of Electrical Workers, AFL-CIO, Local Union 29 (IBEW) filed the Petition to Intervene of International Brotherhood of Electrical Workers, AFL-CIO, Local Union 29 (Petition) pursuant to 52 Pa. Code §§ 5.71 and 5.74 in the above-captioned proceeding. Duquesne Light Company (Duquesne Light) filed an Answer and New Matter to the Petition with a Notice to Plead attached thereto.

In New Matter, Duquesne Light averred that IBEW Local 29 is a labor union that represents approximately 850 employees of Duquesne Light and is also a customer of Duquesne Light. New Matter ¶ 10. This averment was taken from IBEW’s Petition ¶ 2.

IBEW did not have an attorney enter an appearance in this proceeding when it filed its petition to intervene or prior to the filing of Duquesne Light’s Answer and New Matter.

On June 28, 2024, Robert A. Eberle, Esquire and Amanda B. Bundick, Esquire filed a notice of appearance on behalf of IBEW.

The undersigned concludes that IBEW may have an interest in this base rate proceeding that may be affected which may not be adequately represented by the

existing participants and that IBEW may be bound by the action of the Commission in this proceeding pursuant to 52 Pa. Code §5.72(a)(2). No party objected to IBEW's participation and IBEW's participation will not delay this proceeding or impact the litigation schedule.

The technical evidentiary hearings are scheduled for July 29-30, 2024.

THEREFORE,

IT IS ORDERED:

1. That the Petition to Intervene of the International Brotherhood of Electrical Workers, AFL-CIO, Local Union 29 is granted.
