
Please know that I have received your letter dated July 18, 2024, along with the formal rate complaints of your constituents against the proposed rate increase by Aqua Pennsylvania Water and Wastewater Companies (Aqua) at the above docket numbers. The formal rate complaints will be processed and served upon Aqua's counsel and sent to the Administrative Law Judges presiding over the case.

Please understand that the filing of a formal rate complaint will make each of your constituents an active party in the rate case, and they will be given the opportunity to appear at the evidentiary hearings and provide testimony under oath regarding the issues they have raised and why the proposed rate increase should be denied.

Please inform your constituents to save a copy of all documents they send and receive during the litigation, especially those sent by the Administrative Law Judges presiding over the rate case. Also, during the litigation, it is the responsibility of each complainant to provide the Commission with any changes to contact information where they want documents emailed and mailed to them from the other parties and the Commission.
