PREHEARING ORDER # 2

AND NOW this 23rd day of July, 2024, it is hereby ORDERED:

1. DATE AND TIME OF HEARING. the telephonic evidentiary hearings will be held for this case on:

DATE: August 7, 8, 12 & 13, 2024
TIME: beginning at 10:00 a.m. on each date.

2. That all parties shall provide the presiding officers with a list of exhibits that they intend to move into the record no later than August 6, 2024.
3. That all parties shall circulate any hearing exhibits that they intend to introduce at the hearings no later than August 6, 2024.
4. That the presiding officers will provide to the parties a cross-examination matrix by August 1, 2024.
5. That the parties will complete the cross-examination matrix and return to the presiding officers no later than August 6, 2024.
6. That all witnesses for the parties shall be available for cross-examination on all hearing dates indicated in this Order.
7. That if any witness is not available for any of the hearing dates, the party of that witness must notify all parties and the presiding officers no later than August 5, 2024.
8. That the parties shall provide the presiding officers with a status update on any settlement negotiations no later than August 5, 2024.

9. That the parties will provide at least 24-hours notice if there is a need to cancel any of the hearing dates.

10. That the presiding officers will provide the parties with a SharePoint to upload all testimony and evidence that is entered into the record at the time of the hearings, after the completion of the hearings.

11. That if a filing contains confidential or proprietary material, the filing should be clearly marked as such. Any documents that contain confidential or proprietary material should include a cover letter which clearly indicates that there is confidential or proprietary information.

12. That if there is any party who needs an accommodation for a disability to participate in this hearing process may request one. Please call the PUC scheduling office at least five (5) business days prior to your hearing to submit your request.

If you require an interpreter to participate in the hearing, we will have an interpreter present. Please call the scheduling office at the PUC at least ten (10) business days prior to your hearing to submit your request.
