**RE: FirstEnergy PA July 19, 2024 Request for Extension of Filing Deadline for  
the Revised Amended FirstEnergy PA 2024-2028 USECP**

On July 11, 2024, the Pennsylvania Public Utility Commission (Commission) entered an Order on Reconsideration (July 2024 Order) at the captioned dockets directing FirstEnergy Pennsylvania Electric Company (FirstEnergy PA) to, *inter alia*, file and serve a copy of its Revised Amended 2024-2028 Universal Service and Energy Conservation Plan (2024 USECP) within 20 days (*i.e.*, by July 31, 2024). July 2024 Order at 32, OP#5.

On July 19, 2024, FirstEnergy PA filed a letter at the captioned dockets seeking an extension until August 31, 2024, to file its Revised Amended 2024 USECP. FirstEnergy PA Letter at 1.

FirstEnergy PA has indicated that the extension for this filing deadline is necessary as it needs to consult with its IT department on the implementation of some of the directives in the July 2024 Order. FirstEnergy PA asserts that it consulted with the other parties in this proceeding about this proposed extension and that they had no objection. FirstEnergy PA Letter at 1.

Based on the explanation provided and the absence of stakeholder objection, we find it reasonable to grant FirstEnergy PA's request for an extension to the filing deadline.
