The PECO powerlines and my PECO electrical box on my property have been tampered with. There has been PECO technicians out to my home but yet the issues remain. The sockets in my home are hacking all my devices and are affecting my appliances. I reported to PECO that I believe my neighbors on both sides of me were stealing electric. The powerlines on my property were separated and a thin grey wire was loosen. I notice that my Electrical box numbers weren't changing and the lines under the number were moving very slow even though I was using a lot of electrical power. I believe PECO Technicians came on my property unauthorized and have tampered with my PECO powerlines and Electrical wiring and box on my property.

PECO Technicians visited my home on July 2, 2024 and neither one wanted to give me their names. The first Technician was driving a white PECO Truck (# 41-764 and #BERWYN, PA USDOT006612) He did show me a faded ID that you could only read his employee #059743. He told me that their new ID's didn't come in the mail yet. This technician also told me that they sent him because he worked for Comcast in the past. My comcast account and wires were also tampered with and hacked. But a PECO Technician address my Comcast concerns. Why would PECO send a technicians to address Comcast issues. I do have video of the incident.

The other Technician refused to show his PECO ID, he stated "I'm not giving mine;" I don't want my name out there" I work for PECO pointing at his shirt while

stating, "This is good enough" and told me PECO does not provide ID's and told me that he is driving a PECO truck. I told him that he can't come in without showing his ID and he stated, "I'll go wait in the car then" I told him he is supposed to have ID that's PECO rules and he replied, "That's not PECO rules". He still came onto my property, carrying the ladder in. When I seen he was the one who carried the ladder in my yard. I asked him again for his ID and he refused. I told him he has to leave. He was driving a white PECO truck with numbers (# 47-325 and BERWYN, PA USDOT 006612) Both individuals were very rude and very aggressive towards me. I do have a recording of the entire incident. I have pictures of the Technicians and videos of the entire incident.

On June 6, 2024 another PECO Technician came out to my home. I had to ask him to go get his ID when he showed me the ID he covered up his last name. He was driving a white truck but I did not see a PECO logo or any logos on the truck. He also told me that he checked the wires in both of my neighbors backyards but when I checked my security cameras I could see that he didn't check go in their backyards. on. I contacted PECO because I believe my neighbors Joseph Greenhaus and Esther Goldberg who lives at 10920 Nandina Lane and Amin M. Safaev who lives at 10916 Nandina Lane is stealing my PECO Electric. One day I randomly turned off the Electrical power to my home and the neighbors at 10920 power went off as well and I heard them run to the front of their house.

I believe that the Technicians that visited my home were not assigned my workorder and I was never contacted by PECO about the visit. I believe the technicians that came to my home was sent to my home in order to coverup the PECO Powerline wire tampering. I was never shown a workorder from any of the Technicians. I am requesting a Formal hearing. I believe there are Coverups and Conspiracy being conducted.

Because the Televisions in my home, my family cell phones, appliances and other electronic devices are plugged into the electrical sockets in my home, they have all been Hacked/compromised due to the PECO powerline wiring being tampered with. I want PECO to be held responsible for their Technicians actions and behavior. I also want to be reimburse the amounts of my PECO bill for as long as my Electric has been used by others.
