**INTERIM ORDER REOPENING THE RECORD**

On July 30, 2023, Sonceiray Bowman (Complainant) filed a Formal Complaint (Complaint) with the Pennsylvania Public Utility Commission (Commission) against Philadelphia Gas Works (PGW, Company or Respondent). Complainant checked the box on the Complaint form stating that the utility is threatening to shut off her service or has already shut off his service. She stated that she would like PGW to give her a smaller payment arrangement.

A Call-In Telephonic hearing was held in this matter on April 22, 2024. During the hearing, I provided the parties until June 6, 2024 to submit late-filed exhibits.

On May 7, 2024, I received an email from Angela Bowman with several attachments as proposed late-filed exhibits. PGW did not submit any objections. However, after further review of the email from Angela Bowman, I noticed that Ms. Bowman's email was sent to Graciela.christlieb@pgw.com and not attorney Christlieb's email address, Graciela.christlieb@pgworks.com. On July 30, 2024, I forwarded the email, including the proposed late-filed exhibits to attorney Christlieb's correct email address.

Therefore, for the sake of due process, the record will be reopened and PGW will be provided 10 days to provide any objections to Complainant's proposed late-filed exhibits (by Friday, August 9, 2024). The record will close again upon the expiration of the 10-day objection period.

THEREFORE,

IT IS ORDERED:

1. That the Record in the matter of Sonceiray Bowman v. Philadelphia Gas Works at Docket Number C-2023-3041967 is reopened.
2. That Philadelphia shall file any objections to Complainant's proposed late filed exhibits, if it has any, within 10 days of the date of this Order.
3. That upon expiration of the 10-day objection period, the record in this matter shall close.
