Application for License Name Change to add d/b/a Sprague Energy Services**

Sprague Operating Resources LLC ("Sprague") hereby submitted its application for the addition of an assumed name, Sprague Operating Resources LLC d/b/a Sprague Energy Services. Sprague Operating Resources LLC is not changing its name and will continue to serve customers under that name. As instructed by Pennsylvania Public Utility Commission ("Commission") Staff, the process for requesting this approval requires the completion of the *Application for License Name Change*. Sprague is requesting this change to effectuate the integration of certain customers as part of an acquisition and notes that this d/b/a will only apply to new customers as part of the integration and will not apply to any of Sprague's current customers.

The *Application for License Name Change – Checklist* requires certain information to be filed with the Commission. Sprague would note the following:

**Item #2)** As detailed above, Sprague is requesting to add the assumed name; however, all other information requested in this item will remain the same.

**Item #3)** As the d/b/a Sprague Energy Services will only apply to new customers, Sprague respectfully requests a waiver of this requirement as no current customers would be impacted by this change.

**Item #4)** A copy of this filing is being provided to the five statutory agencies and all natural gas distribution companies in the Commonwealth. An executed Certificate of Service is included with this filing.

**Item #5)** A certified check in the amount of \$350 payable to the Commonwealth of Pennsylvania is included with this filing.

**Item #6)** A copy of the Registration of Fictitious Name of Sprague Energy Services with the Commonwealth of Pennsylvania Department of State is included with this filing.

**Item #7)** This requirement is not applicable.



