
Dear Secretary Chiavetta:



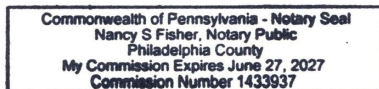
