
Dear Secretary Chiavetta

Please accept this letter reply to the objection filed by counsel for PPL Electric dated June 26, 2024. It is my intent to engage in meaningful settlement discussions to resolve this matter, however, I am a bit disappointed that my initial complaint would justify a "with" prejudice dismissal which should be reserved for the most frivolous filings.
