OPERATING AUTHORITY

Folder 2:

To transport persons upon call or demand, as a common carrier, in the townships of Upper Moreland and Horsham, Montgomery County.

To transport persons upon call or demand, as a common earner, in that part of the Township of Abington, Montgomery County, bounded and described as follows:

Beginning at the intersection of Moreland Road and North Hills Avenue, thence along North Hills Avenue to Fitzwatertown Road, thence northwardly along Fitzwatertown Road to a line running along Patane Avenue as it would be extended westwardly, thence along the line to Patane Avenue beginning at Lindbergh Avenue, thence along a line as Patane Avenue would be extended to the Reading Railroad to Glendale Avenue, thence along Glendale Avenue to Edge Hill Road, thence along Edge Hill Road to Moreland Road, thence along Moreland Road to North Hills Avenue, the place of beginning.

Folder 3:

To transport persons upon call or demand, as a common carrier, in the township of Warminster, Bucks County.

To transport persons upon call or demand, as a common earner, in the Borough of Ivyland and the townships Warrington and Warwick, Bucks County.

Folder 3: Am-A:

To transport, as a common carrier, by motor vehicle, persons upon call or demand in that portion of the township of Upper Southampton, Bucks County, beginning at the intersection of Davisville and Bristol Roads, thence east on Bristol Road to its intersection with Chinquapin Road, thence south on Chinquapin Road to its imaginary intersection with Stump Road (becoming Buck Road) thence south on Buck Road to its intersection with County Line Road, thence west on County Line Road to Davisville Road to point of beginning.

Folder 4:

To transport persons upon call or demand, as a common carrier, in the Borough of Hatboro, Montgomery County.

RULES AND REGULATIONS

- Item 1-** **Advanced Reservations**
(C) Advanced reservations must be made by no later than 3pm on the previous calendar day. Saturday and Monday reservations must be made by 3pm on Friday.
- Item 2-** **Mileage**
 Mileage will be determined by the odometer of the vehicle used.
- Item 3-** **Days and Hours of Operation**
(A)(C) On Monday through Friday between the hours of 5am and 7pm and on Saturdays between the hours of 6am and 5pm are normal service hours. Carrier will accept a reservation for a trip outside the days and hours of normal service hours for a surcharge for each trip. No service on New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day and Christmas Day.
- Item 4-** **Waiting Time- for Exclusive Trips**
(A) (C) A maximum of 5 minutes will be permitted per pick up point. After 5 minutes a fee per minute will be charged to the rider.
- Item 5-** **Escort Service**
(A)(C) A charge will be assessed for all Escorts if an Escort is required for any rider, due to the health, disability or age of a primary passenger. The escort must be capable of providing the necessary assistance to the primary passenger. A letter, signed by a physician, attesting the need of an escort, will be required and must be filed with the carrier. Once the primary passenger is approved for Escort Service, an escort MUST accompany the primary passenger at all times on all trips.
- Item 6-** **Persons in Wheelchairs**
(C) Persons in wheelchairs who wish to ride in a vehicle not equipped with a lift or ramp must have someone available at the origin and destination of the trip that is able to lift the Client into and out of our vehicle and to collapse and stow the wheelchair, into and out of our vehicle, in a secured location. Drivers are not permitted to transfer individuals into our Vehicles or handle the stowing of any wheelchair. Drivers are not permitted to transfer any client from a wheelchair to a seat while riding in a wheelchair traveling in a Wheelchair accessible Vehicle.
- Item 7** **Cancellation of a Reservation**
(C) Carrier reserves the right to charge the filed tariff rate if any passenger fails to cancel their Trip or reservation at least 1.5 hours prior to their scheduled pickup time. Failure to show-up at a designated pickup location within 5 minutes will be consider a "no show". The Carrier reserves the right disallow service to the habitual "no-show".

SCHEDULE of RATES

Section I - Call or Demand

METERED RATES

First 2 miles or fraction thereof **\$15.00 (A) (C)**
 Each addition mile or fraction thereof **\$5.00 (A) (C)**
 Waiting time will be at \$1.00 per minute **\$1.00 (A) (C)**

(A) (C)	All trips that terminate outside our authorized area will be charged the meter fare plus a 25% surcharge.
(C)	All trips outside the authorized area and return will be charged the metered rate plus waiting time.
(A) (C)	Surcharge. Carrier will accept a reservation for a trip outside the days and hours of normal service hours for a \$100.00 surcharge for each trip.
(C)	No service - There is no service on Sundays and on all major holidays such as New Year's Day, Memorial Day, 4th of July or the day it is observed, Labor Day, Thanksgiving and Christmas.
(A) (C)	Exclusive Ride Trips on Saturdays will be charged metered fare plus 25% surcharge.
(A)(C)	Waiting Time – a fee of \$1.00 per minute will be charged for waiting time.
(A)(C)	Escort Service – A charge of \$10.00 per ride will be assessed for escort service.
