
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES (PEAK SEASON) - The Minimum Transportation Charges (Non-Peak Season) will apply with the following exceptions: The last 5 days of each Peak Season month, will have an 6 hours minimum. Crews of van & 2 men during Peak Season will have an 6 hours minimum on all calendar dates. Crews of van & 3 men during Peak Season will have a 4 hours minimum on all calendar days except for the last 5 days of each Peak Season month.

MINIMUM TRANSPORTATION CHARGES (NON-PEAK SEASON) - Sundays and Holidays (any hour): 6 hours at rates named in Columns 1 and 2. Saturdays (any hour) and Weekdays (5:01PM to 6:00AM): 6 hours at rates named in Columns 1 and 4. Weekdays (6:01AM to 5:00PM): 4 hours at rates named in Columns 1 and 3.

NOTE 2 - Any move using a crew in excess of 3 men will have an additional transport flat charge of \$40.00.

NOTE 4 - WAIVER OF MINIMUM CHARGES - CARRIER CONVENIENCE: carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum numbers of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time to complete move plus applicable travel charge.

NOTE AA - A travel charge will apply on all local residential moves in an amount to be determined as follows:

DISTANCE IS BASED ON ACTUAL MILES FROM CARRIER'S FACILITY TO THE FIRST POINT OF ORIGIN AND FROM THE FINAL DESTINATION BACK TO CARRIER'S FACILITY	OVER	NOT OVER	TRAVEL TIME CHARGE
	0 MILES	30 MILES	1 HOUR
	31 MILES	60 MILES	2 HOURS

If mileage from carrier's facility to first point of origin and from final destination back to carrier's facility exceeds 60 miles, the additional travel time charge will be based on 1 hour per each additional 30 miles.

The following items are applicable to shipments transported in excess of 40 miles within Pennsylvania under Tristate Tariff 51-W:

PICKUP OR DELIVERY ON S.I.T. - Schedule H.

Item 301 - PACK/UNPACK - Allegheny-Schedule D; Greene-Schedule C; Washington-Schedule C.

Item 305 - APPLIANCE SERVICING - Allegheny-Schedule D.

Carrier will apply transportation rates for Peak Season on Page 58-B year round.

BOOKING COMMISSIONS

Carrier will implement a 20% booking commission on the linehaul portion of all intrastate Pennsylvania shipments transported in excess of forty (40) miles that are booked for the privilege of a third party relocation company and/or Intrastate PA move requests of over forty (40) miles made by a foreign agent. This additional booking commission will not be levied upon any shipment sold by and booked by Central Van & Storage of Charleston, Inc., t/d/b/a Central Van & Storage Company, Inc.
