DEAR SECRETARY CHIQUETTA,

FOR SOME REASON, POST & SCHILL, P.C. (METHUEN MATTER KNOWN AS P&S) HAS COPIED ME WITH THEIR ANSWER TO PAULA MERCURI US, PPL. SINCE THEY HAVE BROUGHT UP THIS NEW MATTER, I FEEL OBLIGED TO RESPOND.

THIS SEEMS UNCONSCIONABLE IN THIS DAY AND AGE WHEN WE ALL HAVE TO TIGHTEN OUR BELTS BECAUSE OF RUN-AWAY INFLATION.
