I thought Not!

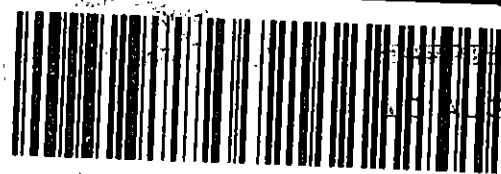
I must now go up to Hershey Hosp.

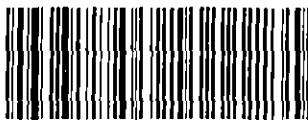
