Dear Mr. Keller:

On July 23, 2024, Duquesne Light Company (Duquesne) filed a request for exclusion of major outage (Exclusion Request) for reliability reporting purposes in accordance with the requirements of the Commission's Order entered May 11, 2004, at M - 00991220. On July 30, 2024 via Secretarial Letter, the Commission sent Duquesne a Data Request seeking additional information related to Duquesne's Exclusion Request. On August 12, 2024, Duquesne filed a response (August 12 Response). The Commission finds that the information provided in the August 12 Response was not responsive to the specific information requested. To assist the Commission in conducting the review of Duquesne's Exclusion Request, please respond with the information requested in Attachment 1. In order to review the additional information requested, the Commission hereby extends the consideration period of Duquesne's Exclusion Request to September 30, 2024.

Please forward the information to the Secretary of the Commission **within ten (10) business days** from the date of this letter. All documents requiring notary stamps must have original signatures.  - a. Duquesne states that there were four specific storm events starting on June 17, 2024, June 19, 2024, June 20, 2024, and June 22, 2024, respectively.
 - i. For each specific storm event provide the following:
 1. The date and time of the first outage for each event.
 2. The number of total customer outages for each event.
 3. The number of trouble cases for each event.
 4. The date and time the last affected customer was restored for each event.
 5. A restoration curve for each storm event.
