Dear Secretary Chiavetta:

We are in receipt of the License Abandonment Data Request issued on July 19, 2024, in the above-captioned matter.

As you are aware, we represent the Bankruptcy Trustee for Astral Energy, LLC, Debtor in this matter. We continue to seek the return of the funds associated with the surety bond filed with the Pennsylvania Public Utility Commission (“PA PUC”) pursuant to 66 Pa C.S. § 2809(c)(1)(i) for the benefit of all of the creditors impacted by the Astral Energy Chapter 7 bankruptcy filing.

Please accept the following in response.

1. Please provide all contracts, agreements, or arrangements that Astral Energy, LLC claims relate to the supply of electricity at retail for which it is making a claim on Bond No. 3131337.

Response: As a company currently in bankruptcy, Astral Energy has no contracts, agreements, or arrangements in place at this time. Astral Energy has filed

for Chapter 7 bankruptcy, which involves the liquidation of the company. Specifically, Astral Energy is the debtor in a Chapter 7 Bankruptcy Proceeding before the United States Bankruptcy Court for the District of New Jersey, Case Number: 23-17424 VFP. Astral filed this voluntary bankruptcy petition on August 25, 2023, and has not sought to continue operation pursuant to 11 U.S.C. § 721. Astral Energy has divested itself of all its customers and is neither procuring nor providing electricity to any retail customers. As such, the foundation for the inclusion of the proceeds of the Bond are predicated upon federal Bankruptcy law and the terms of the Bond.

The trustee for the bankruptcy estate is seeking the recovery of any and all sources of assets for the distribution to the creditors of Astral Energy. See 11 U.S.C. § 544. This list of creditors, provided to the Pennsylvania PUC at the time of the filing of this matter, and included again with this document, includes entities both within the Commonwealth as well as other entities throughout the region. None of these entities are presently covered by any explicit contracts, agreements, or arrangements, but are instead creditors pursuant to the action of the federal Bankruptcy Code, seeking recovery through the express and statutorily defined bankruptcy process.

2. For each contract, agreement, or arrangement, identify specifically how the amount owed relates to the supply of electricity at retail in Pennsylvania in accordance with contracts, agreements, or arrangements.

Response: As noted above, the amounts due and owing based upon the bankruptcy proceeding have been provided in the submission of the initial application for recovery. These amounts far exceed the amount of the underlying Bond, and will be deposited into the bankruptcy estate for distribution by the Bankruptcy Trustee in accordance with federal bankruptcy law. The funding of the bankruptcy estate through the distribution of the Bond valuation will be used for the satisfaction, in part, of the outstanding creditors.

As Astral Energy was operating as a third-party electric supplier in the Commonwealth and elsewhere, the incursion of these costs to the creditors was part of Astral Energy's business and operation. Energy expenses are included in the claims register, notably from Central Hudson Gas & Electric, Algonquin Gas Transmission, LLC, Texas Eastern Transmission, LP, and Tennessee Gas Pipeline, L.L.C., as well as additional costs associated with operating Astral Energy. As such, the inclusion of the proceeds of the Bond will serve to provide compensation for those creditors based upon Astral Energy's operations in the Commonwealth.

3. Please identify the nature of the contract, agreement, or arrangement at issue, including the services(s) provided by Astral Energy, LLC.

Response: Astral Energy had functioned as a third party supplier of electric service for retail customers. As noted, Astral Energy is no longer providing such service, and has instead sought Chapter 7 bankruptcy under the federal bankruptcy code. Astral Energy is no longer functioning as an electric third-party supplier and has not served electrical load in the recent past.

Instead, the trustee for Astral Energy seeks the inclusion of the proceeds of the Bond for the purpose, as set forth in the Bankruptcy Code, of providing recovery to all of the creditors of the company, including those who have been customers or otherwise interacted with Astral Energy predicated upon its Pennsylvania activities. The Bond expressly notes the use and purpose of the Bond, stating:

The condition of this obligation is such ... to ensure the supply of electricity at retail in accordance with contracts, agreements or arrangement. Payment of claims shall have the following priority:
(I) The Commonwealth of Pennsylvania; (II) Electric Distribution Companies for the reimbursement of Gross Receipt Taxer; and (III) Private Individuals.

The creditors at issue here were associated with Astral Energy as suppliers, contractors, and other business entities with business operations that involved Astral Energy and its operation as a third-party energy supplier. The Bond at issue is designed, by its very nature and terms, to serve as a basis for recovery for these entities based upon the bankruptcy claims. Because Astral Energy was unable to provide the service it committed to, each of the creditors listed has been damaged or suffered a loss by reason of violation of the regulations, rules, or standards promulgated by the Commonwealth or similar regulatory obligations from other States.

The Trustee acknowledges and does not object to the distribution first of the Bond proceeds to the Commonwealth. In fact, it is the understanding of the Trustee that such distribution has been claimed and is ongoing. The Trustee continues to assert, however, that the third element of the Bond, providing for the distribution of the Bond to "Private Individuals" is both valid and best served and accomplished by the inclusion of the Bond



proceeds into the Bankruptcy Estate for distribution by the Bankruptcy Trustee to private individuals both within and outside the Commonwealth.
