Re: Natural Gas Supplier License of Sprague Operating Resources LLC d/b/a SPRAGUE ENERGY SERVICES

Dear Mr. Bohan:

On July 17, 2024, Sprague Operating Resources LLC (Sprague Operating Resources) filed a request with the Pennsylvania Public Utility Commission (Commission) to change the name on its license to provide natural gas services, as a supplier, to Sprague Operating Resources LLC d/b/a SPRAGUE ENERGY SERVICES.

Currently, Sprague Operating Resources is licensed as Sprague Operating Resources LLC as a supplier to large commercial (6,000 MCF or more annually) and industrial customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division¹, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc., and Valley Energy, within the Commonwealth of Pennsylvania.

Sprague Operating Resources has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of Sprague Operating Resources LLC's name on its license for the provision of natural gas services as a supplier.

The Secretary's Bureau will issue a new license to Sprague Operating Resources LLC d/b/a SPRAGUE ENERGY SERVICES the right to begin to offer, render, furnish, or supply natural gas services as a supplier to large commercial (6,000 MCF or more annually) and industrial customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division, Peoples Natural Gas Company, LLC – Peoples Gas Division,

Philadelphia Gas Works, UGI Utilities, Inc., and Valley Energy, within the Commonwealth of Pennsylvania.

The Secretary's Bureau and the Bureau of Administration, Financial and Assessments will update the company's name in their computer systems and lists, as appropriate, to be Sprague Operating Resources LLC d/b/a SPRAGUE ENERGY SERVICES.
