**INTERIM ORDER
GRANTING COMPLAINANT’S REQUEST TO RESCHEDULE HEARING**

On June 5, 2024, I issued an Interim Order granting in part and denying in part the Motion for Summary Judgment (Motion) filed by Metropolitan Edison Company (Company, Respondent, or Met-Ed). The Motion was granted in that all claims with regard to smart meters and smart meter installation were dismissed from the Second Amended Complaint filed by Heidi Fiedler (Complainant or Ms. Fiedler). The Motion was denied in that all other claims were permitted to proceed to a hearing.

On June 5, 2024, a Hearing Notice was issued, scheduling an evidentiary hearing for July 31, 2024.

On July 19, 2024, Ms. Fiedler filed a request to reschedule the hearing. She explained that she was already court-ordered to participate in a settlement conference in an unrelated legal matter on the same date and time.

Under the circumstances, I granted Ms. Fiedler’s request.

On July 26, 2024, the Commission issued a Notice, rescheduling the evidentiary hearing for September 12, 2024.

ORDER

THEREFORE,

IT IS ORDERED;

1. That the evidentiary hearing in this matter is rescheduled for September 12, 2024, at 10:00 a.m.
2. That the parties shall be present at and prepared for the evidentiary hearing on September 12, 2024.
3. That no additional continuances or reschedules will be granted on behalf of Complainant, absent good cause *and* proof provided by a third party.
