NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (6:01PM to 5:59AM): 3 hours at rates named in Columns 1 and 4. Weekdays (6:00AM to 6:00PM): 3 hours at rates named in Columns 1 and 3. The minimum transportation charge includes the applicable travel time fee.

NOTE 5 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE 6 - When carrier is requested to hold the shipment overnight for the convenience of the customer, an additional fee of **\$250.00** per truck per night will apply.

NOTE 7 - If bulky items, such as, a hot tub or gun safe are included in the shipment, an additional fee of **\$300.00** per item will apply.

◆ NOTE 8 - When a piano or organ are included in the shipment, the following charges will apply in addition to all other applicable charges:

Spinnet Piano or Organ	\$150.00 per item
Console or Upright Piano	\$250.00 per item
Baby Grand or Grand Piano or Large Organ	\$450.00 per item

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
