**PHILADELPHIA GAS WORKS’
MOTION FOR CONTINUANCE AND PREHEARING CONFERENCE**

Pursuant to 52 Pa. Code §§ 1.15 and 5.103, Philadelphia Gas Works (“PGW” or “Respondent”) hereby files this Motion to Continue the evidentiary hearing scheduled for Tuesday, September 3, 2024, and to request a prehearing conference pursuant to 52 Pa. Code § 5.222 to obtain clarification regarding the Order for Further Hearing dated August 1, 2024. In support of this Motion, PGW states as follows:

1. By notice issued July 8, 2024, the Commission scheduled a further telephonic hearing in this matter for Tuesday, September 3, 2024.
2. The Order for Further Hearing dated August 1, 2024 states that among of the issues to be addressed during the further telephonic hearing are “the inspections that are the subjects of PGW Exhibits 14-15.”
3. Neither of the PGW employees who conducted inspections that are the subjects of PGW Exhibits 14-15 are available to testify on Tuesday, September 3, 2024 (one due to a vacation the other due to training).
4. PGW is requesting that the further telephonic hearing schedule for Tuesday, September 3, 2024 be continued to a later date.
5. PGW has spoken with the Complainant, Ms. Brisbane, via telephone to discuss PGW’s request.
6. Ms. Brisbane has stated that he has no objection to PGW’s Motion.
7. During the course of the conversation, the Order for Further Hearing dated August 1, 2024 was discussed and both parties desire more clarification as to the purpose and scope of the further telephonic hearing.
8. PGW requests that prehearing conference be scheduled in this matter to obtain clarification

regarding the Order for Further Hearing dated August 1, 2024 and the further telephonic hearing.

WHEREFORE, PGW requests that the Commission grant PGW's Motion and continue the hearing scheduled for Tuesday, September 3, 2024, and schedule a prehearing conference in this matter.
