Trespassed on to my property Threw a closed gate to take my old meter on July 15th. And trespassed again on July 16th to replace meter with a new one.


Did this without telling me they were coming on my property. I have animals that are usually out.

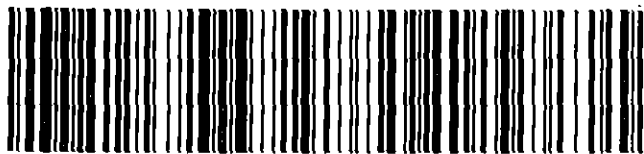
