

Please be advised that I am general counsel to Newtown Artesian Water Company, Inc. (“NAWC”), in the above-referenced matter. By electronic filing, I am submitting NAWC’s Supplement No. 160 to its Tariff Water – Pa. P.U.C. No. 9 (“Tariff No. 9”). Supplement No. 160 is being filed pursuant to Ordering paragraph number 3 of the Order of the Public Utility Commission (the “Commission”) dated August 22, 2024 (the “Order”).

On July 19, 2024, NAWC filed Supplement No. 158 to Tariff No. 9. Per its terms, Supplement No. 158 is intended to become effective on September 18, 2024. As directed by the Order, Supplement No. 160 suspends, by operation of law, the effective date of Supplement No. 158 until April 18, 2025, unless permitted by Commission Order to become effective at an earlier date.
