We are writing to inform you that Frontier Utilities Northeast, LLC ("FUNE") (~~A-2013-2387060~~) has agreed to acquire the Pennsylvania natural gas customers of Approved Energy II, LLC ("Approved" or "we") (~~A-2022-3033041~~). We are working diligently to ensure that all customers and stakeholders are properly informed and no disruption in supply services will occur for any customer. FUNE holds the necessary eligibility to serve the customers included as part of this transaction. In addition, the contracts to be assigned specifically indicate that the agreements can be assigned by Approved.
