Dear Mr. McCarthy:

We are sending this letter to you, as a PECO Energy Company (PECO or the Company) customer who filed a Formal Complaint with the Public Utility Commission (PUC) in the above case. We want to notify you that the Company, the Commission's Bureau of Investigation and Enforcement, the Office of Small Business Advocate, the Office of Consumer Advocate (OCA), and other active parties have proposed a Joint Petition for Non-Unanimous Settlement (Settlement) to the Commission to resolve the issues raised in this case. **If you have any comments regarding the Settlement, you must submit them to Administrative Law Judges Marta Guhl and Darlene D. Heep, by September 12, 2024.**

On August 30, 2024, the Company filed the proposed Settlement with the PUC and served a copy of the proposed Settlement on Judges Guhl and Heep and all parties, including you.

Because you filed a Formal Complaint in this case, you have the following options:

- You may join in the proposed Settlement. To do so, please sign and return the enclosed Signature Page (enclosed with this letter) to the Secretary of the Commission with copies to Judges Guhl and Heep **by September 12, 2024**. Signing the Signature Page means that you agree to have your Formal Complaint discontinued with the approval of the proposed Settlement.
- You may object to the Settlement. You must submit objections to the Secretary of the Commission with copies Judges Guhl and Heep by letter **by September 12, 2024**.
- You may choose to do nothing.

This is your opportunity to express your opinion, if you wish, on the proposed Settlement before Judges Guhl and Heep issue their Recommended Decision for the PUC's consideration.
