In accordance with the Commission's Order dated December 1, 2023, and amended by the Order entered August 27, 2024, Bessemer & Lake Erie Railroad Company (B&LE) hereby reports as follows:

1. As required by the Order, all work necessary to complete the repair and alteration to the subject crossing was to be completed in a manner satisfactory to the Commission on or before September 30, 2024, and on or before said date, Bessemer & Lake Erie Railroad Company was required to report to this Commission and the Pennsylvania Department of Transportation the date of the actual completion of the work.

This correspondence constitutes B&LE's notice to the Commission and the Pennsylvania Department of Transportation and all involved parties of the actual completion of the work as required by the Order.

Accordingly, B&LE is thereby requesting a final inspection of the repair work be scheduled.
