John Coogan, Administrative Law Judge,

Previous—hearing phone conference I certified mail return receipt stating I requested face to face hearing scheduled on September 13, 2024. You requested a pre-hearing conference by phone to find out if and to persuade me to have a phone hearing on September 13, 2024 even though you already received my decision to have face to face.

A surprise to me and in my opinion unethical Daniel Garcia for First Energy/Met Ed phoned me prior to the pre-hearing phone conference. He reiterated per documents that they were in agreement to relocating the (DARPA) SMART METER that was put on my house WITHOUT INFORMED CONSENT. During the conversation he expressed that they were not inclined to do the trip to Harrisburg for the face to face in September and I MAINTAINED I had no problem going to Harrisburg for the face to face with my witnesses. During the pre-hearing phone conference, Daniel Garcia blatantly lied speaking for me and putting words in my mouth without my authorization and claimed that I said it was a hardship for me to travel to Harrisburg for the face to face in September of which you listened to his lie and refused to listen to me. Referencing his lies I asked, "How am I supposed to work with someone who lies?" and you responded that you would not/could not answer what goes on between the [opposing] attorney and me; but you listened to him. You obviously listened intently when he lied stating my name that I said I didn't want to travel to Harrisburg. I object that you entertained Daniel Garcia's lying comment as well as what appeared to be slander and perjury and perhaps identity theft by using my name for his benefit and/or for the benefit of his corporation. I am full aware that you all are part of the corporation and I am not; I am a free living woman. I object that you appeared to permit Garcia to (1) continue using my name for his blatantly lies and, (2) he did not have my authorization to speak on my behalf at any time, (3) and you ignored my objection refusing to answer my question but allowed the above, (4) Please reference the word "lying" in The Webster's Dictionary and in Black's Law Dictionary; also see perjury.

Other reasons to have face to face in September:

(1) It is what I previously advised you I wanted, entitled to and my right.

(2) By law, I have the right to face my accuser face to face. Garcia's demonstrative lying on the phone appears to be a lot easier than lying face to face. See lying in Webster's Dictionary and Black's Law Dictionary.

(3) During the pre-hearing phone conference you asked me [to mute my phone due to my dogs].
Reminder my dogs live here; it is our home.

(4) At another point when you didn't want me to continue speaking calling Daniel Garcia out for lying, transcriber could not hear us speaking.

(5) When you interjected to prevent me from speaking, the transcriber mentioned she had a hard time making out what was being said during your desired pre-hearing phone/telephonic conference.



Therefore I reserve the right to add additional witnesses. Perhaps you all might want to reference Dr. Curt Bennett for one.

(8) Sharing information I discovered that All States are Private Corporations. Commonwealth of Pennsylvania EIN 23-6003062. Please check for accuracy in case you need it for your Corporation Standing. I am not a corporation. I am a free living woman.

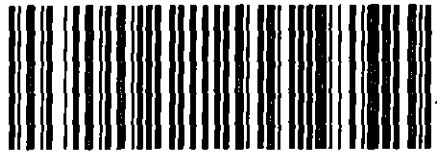

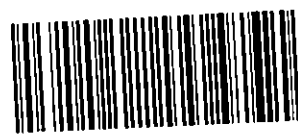
