Dear Secretary Chiavetta:

Enclosed on behalf of City of Lock Haven Water Department (“Lock Haven”), please find Supplement No. 22 to Water – PA P.U.C. No. 1 which suspends the rate effective period to June 27, 2025.

Pursuant to the Commission Order entered on July 11, 2024, the Commission instituted an investigation of Lock Haven’s proposed rate request, assigned the matter to the Office of Administrative Law Judge for Alternative Dispute Resolution, if possible, and the scheduling of hearings, and directed Lock Haven to file a tariff supplement announcing that the tariff filed on May 24, 2024 was suspended until March 2, 2025, unless permitted by Commission Order to become effective at an earlier date. Lock Haven and the parties subsequently agreed to participate in mediation of this matter. On July 19, 2024, Lock Haven filed Supp. No. 21 further suspending the effective date for an additional 60 days pursuant to 52 Pa. Code § 69.392(d)(2), until May 1, 2025. Lock Haven now submits Supp. No. 22 to further extend the suspension period to June 27, 2025, in order to allow additional time for mediation.
