ORDER MODIFYING LITIGATION SCHEDULE

By e-mail dated September 12, 2024, I was informed that Aqua Pennsylvania, Inc. (Aqua) and its subsidiary, Honesdale Consolidated Water Company (HCWC) (Aqua and HCWC, Joint Applicants), and the Office of Small Business Advocate (OSBA) the active parties in this proceeding were engaged in settlement discussions. The Joint Applicants and OSBA also indicated that they had made significant progress toward a full settlement and requested that the litigation schedule established in the Prehearing Order issued August 19, 2024 be modified slightly to facilitate the conduct of their settlement efforts. More specifically, counsel to the Joint Applicants requested “a one week extension of time to file its Direct Testimony, to Tuesday, September 24, 2024.” Counsel for the Joint Applicants stated that OSBA concurred in this request for an extension of Aqua’s Direct Testimony due date.

In view of these developments, the request will be granted and the litigation schedule contained in the Prehearing Order, dated August 19, 2024, will be modified.
