Dear Mr. Schmidt:

On August 9, 2024, the Pennsylvania Public Utility Commission (Commission) received Utiliz Services, LLC's Application for an Electric Generation Supplier (EGS) license. On August 9, 2024, Utiliz Services, LLC provided additional information for the Application.

Sections 1.e, 7.b, 11.a and 11.b of the Application were incomplete or not properly completed (ie. secondary contact for customer complaints, financial documents missing, affidavits must list Utiliz Services, LLC as the Applicant, not C. Thomas Schmidt). In order for the Commission to accept the Application for review, these deficiencies must be corrected. Failure to respond timely will result in the Application being deemed rejected<sup>1</sup> and the docket will be closed.

Use of the efiling system will ensure that submissions by the company are received timely and receipt can be verified.


