**ORDER CANCELLING HEARING**

This Order is issued pursuant to the authority granted to presiding officers under the procedural regulations of the Pennsylvania Public Utility Commission at 52 Pa. Code §5.483. By this Order, and for the reasons that will be explained, below, the hearing in this case presently scheduled for September 26, 2024, is cancelled.

As stated, an evidentiary hearing in this case matter has been scheduled for September 26, 2024. On September 18, 2024, however, an employee of Arcturus Home Care, LLC (Arcturus or Complainant) in response to a query from the Judge, advised the undersigned by email that Arcturus has not retained counsel in this contested proceeding and that Arcturus filed for bankruptcy at a date unspecified. The undersigned was also informed that the bankruptcy case was, “dismissed,” as Arcturus is without assets.

The procedural rules and regulations of the Commission at 52 Pa. Code § 1.21 *et seq.*, require that Arcturus, as an LLC, be represented in this case by an attorney. To date, no attorney has entered an appearance on behalf of Arcturus. It was in response to an inquiry about this lack of representation that the undersigned was informed about the bankruptcy proceeding involving Arcturus. Before this matter can go forward, Arcturus must retain counsel, and a prehearing conference must be scheduled to ascertain whether Arcturus still exists as a corporate entity as well as to clarify the status of the bankruptcy proceeding.
