Attached on behalf of UGI Utilities, Inc. – Electric Division (“UGI” or the “Company”) please find Revised UGI Electric Statement Nos. 2 (Revised) and 2-R (Revised) – the Direct and Rebuttal Testimony of Stan C. Faryniarz.
