PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention in this proceeding before the Commission.

On July 23, 2024, The York Water Company (York or Company), filed with the Commission a Petition seeking approval of a Lead Service Line Replacement Program (LSLR Program) and tariff revisions that will allow it to replace customer-owned lead service lines (COLSL), and to recover those costs as provided in Section 1311(b)(2) of the Public Utility Code, which was added to the Public Utility Code pursuant to Act 120 of 2018. 66 Pa. C.S. § 1311(b)(2).

The proposed LSLR program and plan will allow the Company to recover the costs for LSL replacements, both Company-owned and customer-owned, through its base rates and DSIC. 66 Pa. C.S. § 1311(b)(2). For customers, the LSLR plan has the potential to provide both financial and public health benefits.

The Consumer Advocate has determined that it is necessary to intervene in this proceeding to protect the interests of York's customers. The Office of Consumer Advocate opposes York's Petition and requests that the matter be referred to the Office of Administrative Law Judge to hold appropriate proceedings. The Office of Consumer Advocate will seek to ensure that the Company develops a fair and equitable way to implement its program so that the public health and safety issues are fully addressed.
